Description

Maxum is a concentrated supplement for horses, formulated to provide supplemental vitamins, minerals and amino acids that may be lacking or in insufficient quantities in the horse's regular feed ration.

Ingredients

Wheat Middlings, Dehydrated Alfalfa Meal, Monocalcium Phosphate, Ferrous Sulfate, Soybean Meal, Ground Corn, Lignin Sulfonate, Salt, Choline Chloride, Potassium Chloride, Magnesium Oxide, L-Lysine, Sodium Selenite, Yucca Schidigera extract (a natural flavoring agent), Lactobacillus acidophilus Fermentation Product Dehydrated, Dried Seaweed Meal, Calcium Carbonate, Vitamin A supplement, Vitamin D₃ Supplement, Vitamin E Supplement, Vitamin B₁₂ Supplement, Riboflavin, Niacinamide, d-Calcium Pantothenate, Menadione Sodium Bisulfite complex, Folic Acid, Pyridoxine Hydrochloride, Thiamine mononitrate, Biotin, Manganous Oxide, Zinc Oxide, Copper Oxide, Ethylenediamine Dihydriodide, Cobalt Carbonate, and Propionic and Acetic Acid (as preservatives).

Feeding Directions

Maxum can be mixed into a completed feed at the rate of 12 ½ lbs per ton. For individual supplementation, feed 1 to 2 ounces daily.

CAUTION

Intake of supplemental selenium should not exceed 0.1 ppm on a complete ration basis. Follow label directions. The addition to feed of higher levels of this premix containing selenium is not permitted. Excessive amounts of selenium may be toxic. Store in area inaccessible to children and animals.

Storage

Close container after each use. Store in a cool, dry place.
